Student Affairs 101

WCPA is pleased to offer the 12th Annual Student Affairs 101 Conference for undergraduate students interested in pursuing a career in student affairs. The conference will be held on October 12 and 13, 2012, at the Wilderness Resort in Wisconsin Dells, WI.

The two-day Student Affairs 101 Conference brings undergraduate students from across the state together with graduate students and professionals in the field of student affairs. On day one, students join the graduate student and professional conference for lunch and a keynote speaker. In the afternoon, students have the opportunity to explore various topics in student affairs through breakout sessions led by student affairs professionals. On day two, students break into track sessions designed to provide a targeted experience for students at various stages of the decision making process about pursuing a career in student affairs. Each track is a three-hour experience to help students answer the question, "Where do I go from here?"

The Exploring Track is for students considering the possibility of a career in student affairs and covers topics like why pursue a career in student affairs, current trends and issues in higher education, and reflection activities to answer the question, "What do I need to do to find out if student affairs is the profession for me?"

The Committed Track is for students who have decided to pursue a career in student affairs and who have more than a year of undergraduate education remaining. Topics include the graduate school search process and discussions about whether or not to pursue a graduate degree, ethical decision making, and reflection activities to answer the question, "What experiences should I gain to prepare me for a career in student affairs?"

The Searching Track is for students who have committed to a career in student affairs and will be job or graduate school searching within the year. The Searching Track covers topics including how to navigate placement exchanges, the GRE, ethical decision making, conversations with seasoned professionals, and reflection activities to answer the question, "What do I need to do to be more prepared for my search process?"

There are two registration options for students interested in attending student affairs 101 this year. For \$50, students may register for the conference, which includes lunch and refreshments on Friday and breakfast and lunch on Saturday, as well as all conference sessions and materials. Students registering at this rate are responsible for their own lodging accommodations.

For \$75, students may register for the conference, including everything provided at the \$50 rate, and including lodging and the resort fee. Lodging is based on four person occupancy. Students may submit a specific roommate request at the time of registration, and we will do our best to honor the request, though requests are not guaranteed. The deadline for those students wishing to register at the workshop and lodging rate is Friday, October 5. Lodging cannot be guaranteed after that date.

Advisors accompanying students to Student Affairs 101 may register for \$25. Lodging is not included.




To sign up to compete in the Case Study, graduate students may indicate their interest when registering for the conference. They will then receive



Book Review:

The Traveler's Gift by Andy Andrews


If your looking for a book that is easy to read and provides some introspective analysis in an indirect way than this definitely a book you will enjoy. The Traveler's Gift takes a walk through history but in a completely unique way. You will follow the journey of David Ponder whom it would be light to say is having a bad day. David encounters a life-changing event that plunges him back and forth through time meeting mentors per se that each have a "decision" to provide him. I found this book to be comforting while at the same time expanding as it allowed me to think about my life journey in a new way. This isn't the type of book you can read and follow step A. B. C. and end up with results, but the book does provide some context to begin to ask new questions about your past, present and future. Below is a list of the seven decisions with a bit of context after them.

- 1. The buck stops here. I am responsible for my past and my future.
- 2. I will seek wisdom. I will be a servant to others.
- 3. I am a person of action. I seize the moment. I choose now.
- 4. I have a decided heart. My destiny is assured.
- 5. Today I will choose to be happy. I am the possessor of a grateful spirit.
- 6. I will greet this day with a forgiving spirit. I will

forgive myself.

7. I will persist without exception. I am a person of great faith.

I challenge you that if you have a moment pick up The Traveler's Gift and delve into history and learn from the metaphors of the past. The book will leave you wondering if the author had a time machine and was actually at some of these events as he recalls critical moments for our country.
